# University of Nebraska-Lincoln and Public Policy Center Focus on Preventing Targeted Violence



Recognizing the signs and getting them reported to people trained to assess threats and avert violence is the focus of work by the University of Nebraska-Lincoln's **Targeted Violence Research Team** and the University of Nebraska Public Policy Center (PPC). Dr. Mario Scalora,

director of the PPC and Dr. Denise Bulling, senior research director at the PPC, are both nationally recognized threat assessment experts. Scalora supervises research into threat detection, assessment, and management and works with Bulling and others to translate the findings into training an ever-widening group of people on how to assess and manage threats for the best outcomes. This report, released this month, features important topics and issues collected

through interviews with residents in six high poverty or highly mobile neighborhoods, identified through the **Lincoln Vital Signs** report. These neighborhoods include Belmont, Clinton, Everett, Hartley, Near South, and University Place. Collective Impact Lincoln is a partnership among **Civic Nebraska**, **Nebraska Appleseed**, and the **South of Downtown Community Development Organization**.

# **Spotlight of the Month**

#### Suicide Prevention Course Reaches Over 10,000 School Educators and Staff

The Public Policy Center's management and creation of the "Building a Suicide-Safe School Community" course has resulted in more than 10,500 educators and staff completing the training in school districts throughout Nebraska during the 2020-2021 school year.



Educators and staff can take this course to meet their required suicide prevention and mental health training requirement and it is part of a statewide effort to increase suicide prevention in schools. This course was developed by Dr. Don Belau and the NUPPC's Dr. Denise Bulling, Dr. Kate Speck, and Ryan Lowry-Lee.

This free online interactive training is designed for faculty and staff, introducing concepts that help staff understand what to do if a student is contemplating suicide and what to do to appropriately respond to a suicide using postvention measures. Postvention is an organized response in the aftermath of a suicide.

#### **Research Specialist Serves as Reviewer on Suicide Prevention Technical Package Developed by the CDC**

Senior Research Specialist Quinn Lewandowski accepted an invitation to serve as an expert reviewer for a suicide prevention technical package developed by the Centers for Disease Control and Prevention. Quinn was able to provide feedback that will be incorporated to improve the quality of the technical package, which offers communities and states a core set of strategies to achieve and sustain substantial reductions in suicide based on the best available research evidence.



The CDC initially developed *Preventing Suicide: A Technical Package* of *Policy, Program, and Practices* in 2017. Since then, more research has emerged and new needs have surfaced with COVID-19. Through a cooperative agreement with the CDC, **Prevention Institute** has partnered with **RTI International** and the **Center for Law and Social Policy (CLASP)** to update the technical package content and develop **modules** that provide a foundation for activities during periods of infrastructure disruption, specifically for government agencies and community-based organizations operating at the state and local levels.

#### **Husker Speech Debate Team Ranks Sixth Nationally**



The **Huskers Speech Debate Team** earned 6th place as a team at the American Forensic Association this month. This is the second highest Husker ranking in 150 years! PPC Undergraduate Research Assistant Cole Shardelow was a semifinalist in the competition for his Impromptu speech. Cole is a philosophy major and works at the Nebraska Attorney General's Office. Clare Frances Kennedy, a communication studies major, was a finalist, earning 4th place in Impromptu and 6th place in Drama.
