

New Website and Newsletter Offer Resources on Behavioral Threat Assessment and Management



The Public Policy Center recently launched a new threat assessment website and quarterly newsletter focused on Behavioral Threat Assessment and Management training across the state. The website highlights the PPC's threat assessment and management activities and provides related resources and information. The quarterly newsletter notifies threat assessment professionals, law enforcement, and school administrators about upcoming trainings and the latest research happening in the area of threat assessment. In the next two years, the project will provide trainings to help behavioral health professionals assess violence as part of their regular practice.

Safe2Help Nebraska Status Report Shows Impacts of Anonymous Reporting Line for Nebraskans




The latest **Safe2Help Nebraska** progress report shows the impact of the Safe2Help anonymous reporting line for Nebraskans. The line received 2,716 tip reports since January 2020. The reporting line serves 64% of the student population across 90 Nebraska school districts. 49% of all tips came from a mobile device, 36% from the web, and 15% via a phone call. The largest number of tips (22%) concerned issues related to bullying. See the **news coverage**.

Resources on School Preparedness Help Schools

Prepare for Unexpected Events and Emergencies



The **disaster mental health website** includes a new webpage focused on school preparedness. It includes emergency operations situation manuals from tabletop exercises to help school administrators, staff, and community partners (such as first responders and emergency managers) prepare for emergencies. The scenarios, which include a bus accident, outdoor sports event, tornado incident, and cybersecurity phishing attack, help schools and communities test and improve their emergency operations plans.
